1. Adam Clark presented an update on the Athletic Department.
2. The board approved the financial report for the month of May.
3. The board authorized the Treasurer to make necessary transfers, advances, and appropriation modifications to close the books for FY17.
4. The board approved the transfer of \$34,974.47 from 006 Food Services to 035 Termination Benefits.
