Carrier is replacing piping and Y-joints. GAHS and GAMS is complete. Washington will have its start next week with Green within five days. Work at Rio Grande has not yet began. Work will be completed in evenings focusing on one unit at a time to maintain control as work is completed.

Superintendent Wright added bids are back on the STEAM project. Working with Setterlin through the process. Drains and fencing are next for the Washington playground project.

President Angell announced the next regular meeting is set for 6:30 p.m. on August 17, 2022 at Gallia Academy Middle School Library.
