 March 15, 2023

The Gallipolis City School District Board of Education met at 6:30 p.m. on March 15, 2023 at Gallia Academy Middle School Library located at 340 Fourth Avenue, Gallipolis, OH 45631.

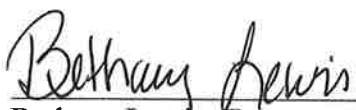
